### MODE OF MEETING

The Forty-First Annual General Meeting ("41st AGM") of the Company will be conducted fully virtual meeting through online meeting platform via TIIH Online website at <a href="https://tiih.online">https://tiih.online</a> provided by our Share Registrar, Tricor Investor & Issuing House Services Sdn Bhd. All meeting participants including the Chairperson of the meeting, board members, senior management and shareholders are required to participate in the meeting online. Physical meetings or gatherings, irrespective of the number of participants involved are prohibited.

An online meeting platform used to conduct the meeting can be recognized as the meeting venue or place as required under Section 327(2) of the Companies Act 2016 provided that the online meeting platform.

# **REMOTE PARTICIPATION AND VOTING FACILITIES ("RPV")**
